#### **1. LIMITED WARRANTY COVERAGE**

The STACKRACK BATTERY SYSTEMS Lithium Iron Phosphate Batteries SR5K-UL Series as supplied and distributed by STACKRACK BATTERY SYSTEMS and its authentic distributors, are warranted by STACKRACK BATTERY SYSTEMS, LLC (STACKRACK INC.) against manufacturing defects in materials and workmanship. Within the United States of America Region, the limited warranty period begins on

- (i) the manufacturing date plus 6 months or
- (ii) the date the Covered Product is activated at the Original Location by STACKRACK BATTERY SYSTEMS certified installers (such applicable date referred to herein as the "Warranty Activation Date).

Whichever comes first and ends on (iii) 10 years from the warranty activation date; or 6000 discharge cycles, 90%  $DOD^1@77^\circ F$  ret 70%; or 2000 discharge cycles, 100%  $DOD^2@77^\circ F$  ret 70%;. The pre-condition of the valid Limited Warranty shall be as follows:

- (i) The ambient temperature during the operation of the Subject of the Warranty must not fall below 32°F or exceed 113°F;
- (ii) The Subject of the Warranty should not be exposed to a temperature exceeding 122°F;

To be eligible, all STACKRACK BATTERY SYSTEMS Products must be installed as per the guidelines given in the SR5K-UL Series manual and installation guide provided with the battery pack.

reseller (b) and properly installed by a licensed professional; (c) and is installed in the United States of America. This Limited Warranty does not cover faults in design or installer error such as, but not limited to, reverse polarity or misuse of system wide equipment or inaccurate programming of all auxiliary equipment in your system.

The liability of STACKRACK BATTERY SYSTEMS under this Limited Warranty shall be limited to the repair or replacement of the Product, at our sole discretion. STACKRACK BATTERY SYSTEMS will not be responsible for any other types of losses or costs of any type pertaining to the use of its products. If the STACKRACK BATTERY SYSTEMS product is found to be defective as a result of any manufacturing defect in materials and workmanship during the Limited Warranty Period, STACKRACK BATTERY SYSTEMS Product. (ii) replace the Product, (ii) replace the Product. (iii) Replace the Product with a similar STACKRACK BATTERY SYSTEMS Product. If a STACKRACK BATTERY SYSTEMS Product is replaced, the defective Product will become the property of STACKRACK BATTERY SYSTEMS and must be returned to STACKRACK BATTERY SYSTEMS.

# 2. Remedies.

If the Product fails to comply with the above Limited Warranty, STACKRACK BATTERY SYSTEMS will, in its sole discretion, either repair the Product (using new or refurbished parts) or replace the Product with an equivalent product (new or refurbished), and STACKRACK BATTERY SYSTEMS will not bear the cost of shipping. If the Product is repaired or replaced under this Limited Warranty, STACKRACK BATTERY SYSTEMS will bear the shipping cost of returning the Product to the warehouse of original purchaser, and the remainder of the original warranty period will apply to the repaired or replacement product. Under no circumstances will the original warranty period be extended as a result of the Product being repaired or replaced. If the Product is failed during transportation and need to be replaced, STACKRACK BATTERY SYSTEMS will not bear the cost of shipping or repairing.

# 3. Exclusions of Warranty

This Limited Warranty does not apply to any defect or energy capacity shortfall resulting from any of the following, each of which may result in your Limited Warranty being voided:

1) Abuse, misuse, negligence, accidents or force majeure events, including but not limited to lightning, flood, earthquake, fire, extreme cold weather, or other events outside the reasonable control of STACKRACK BATTERY SYSTEMS.

2) Storage, installation, commissioning, modification or repair of the Product,

or opening of the external casing of the product, that is performed by anyone other than STACKRACK BATTERY SYSTEMS or a STACKRACK BATTERY SYSTEMS certified installer.

 Failure to operate or maintain the product in accordance with the User Manual.
Any attempt to modify the product, whether by physical means, programming or otherwise, without the express written consent of STACKRACK BATTERY SYSTEMS.

5) Removal and reinstallation of the product at a location other than the original installation location, without the express written consent of STACKRACK BATTERY SYSTEMS.

6) Inverter or charger failure.

7) Transportation, including but not limited by dropping, trampling, deforming, impacting, or spearing with a sharp item.

8) The Product has been connected with different type battery modules.

#### In addition, this Limited Warranty does not cover:

1) Normal wear and tear or deterioration, or superficial defects, dents or marks that does not impact the performance of the Product.

2) Noise or vibration that is not excessive or uncharacteristic and does not impact the product's performance.

3) Damage or deterioration that occurs after the expiration or voiding of the warranty period.

4) Theft of the Product or any of its components.

### 4. General Provisions

This warranty is subject to the laws of USA.

If any provision in this document is unenforceable, illegal or void or makes this document or any part of it unenforceable, illegal or void, then that provision is severed and the rest of this document remains in force.

If any provision in this document is unenforceable, illegal or void in one jurisdiction but not in another jurisdiction or makes this document or any part of it unenforceable, illegal or void in one jurisdiction but not in another jurisdiction, then that provision is severed only in respect of the operation of this document in the jurisdiction where it is unenforceable, illegal or void.

### 6. Claims Process.

In order to make a claim under this Limited Warranty, please contact the STACKRACK BATTERY SYSTEMS certified installer who sold you the Product. If you are unable to contact the STACKRACK BATTERY SYSTEMS certified installer who sold you the Product, or if you purchased the Product directly from STACKRACK BATTERY SYSTEMS, you should contact STACKRACK BATTERY SYSTEMS at the address, email address or telephone numbers mentioned below. For a warranty claim to be processed, it must include (i) proof of the original purchase of the Product and any subsequent transfers of ownership, (ii) a description of the alleged defect(s), and (iii) the Product's serial number and original installation date. Prior to returning any Product to STACKRACK BATTERY SYSTEMS, you should obtain an RMA (Return Merchandise Authorization) number from STACKRACK BATTERY SYSTEMS by submitting a Service Request Form at the link indicated below.

After receiving the RMA number, you must pack the Product authorized for return, along with the information described above, in the original STACKRACK BATTERY SYSTEMS Product shipping container or packaging providing equivalent protection. And you only need to bear the shipping cost of returning the Product to the warehouse of original purchaser. STACKRACK BATTERY SYSTEMS is not responsible for shipping damage caused by an improperly packaged Product, the repairs this damage might require, or the cost of these repairs.
